[The following activities <u>will not meet</u> <u>during July and August</u>: Collectors, Computer Lessons, History and Roundtable. They'll resume in September. -Ed.]

Many consumers become disheartened when charged service fees by their cell phone providers, banks, airlines or other service providers. These fees have become particularly painful during the recent period of high inflation. With this in mind, the Prime Gentlemen (PG) Board of Directors has decided to eliminate the service fees for members who choose to utilize the PayPal payment option for membership renewal or prepaid meal

Once the "Christian" right got Roe v. Wade overturned, I thought to myself "Who will they go after next?" It appears to be us.

I remember customers confronting and threatening store workers regularly during the height of the mask requirements. In every case store managers refused to back down to those people and ejected ornery customers. They didn't change their policy.

comment was that they moved the displays to the back of the store to protect workers. What makes this more disturbing is that Target has been one of our best supporters. The Human Rights Campaign has always given them a 100% rating.

Budweiser suffered a financial backlash when they hired a Trans influencer to do a Bud Light commercial. They pulled the commercial off the air. If our allies are cowed by the anti-LGBTQ haters, then we are in serious trouble.

There is a new expression called "rainbow" washing." It refers to companies who make public displays of their support of

the LGBT community during Pride month but do little the rest of the year. It's more of a marketing ploy than authentic support.

As a community and as individuals we need to respond in some way. There are hundreds of major companies who support the LGBTQ community in their hiring practices, recognition of gay marriages, inclusion of gay couples in their advertising, sensitivity training and LGBTQ initiatives.

We need to return their support by letting them know who we are. A simple letter or email to a CEO by hundreds of consumers may do more than boycotting Target or Budweiser.



In the 1956 presidential election, Dwight Eisenhower defeated Adlai Stevenson and Richard Nixon remained his Vice President. The Broadway musical My Fair Lady opened in New York City and videotape was first demonstrated at a convention in Chicago.

In the same year, President Eisenhower signed the Federal Aid Highway Act, creating the Interstate Highway System. An Alabama District Court ruled that state bus segregation laws were unconstitutional which resulted in the Montgomery bus boycott.

Elvis Presley performed "Hound Dog" on several 1956 TV shows and scandalized the audience with his suggestive hip movements. Cecil B. DeMille's masterpiece, The Ten Commandments, was also released that year.

expenses. These service fees are now paid out of our treasury rather than by the individual member.

For members who are unfamiliar with the service, PayPal is an online payment platform that facilitates payments between individuals and businesses or organizations. PG has utilized PayPal for

several years, allowing members to make online payments without the need to send a check and incur postage expense, while also eliminating the risk of having a payment lost in the mail.

To make use of this service, simply access the PG online home page and navigate to either the "Membership" or "Reservation" tab. From there, select the appropriate option from the drop-down menu and proceed by clicking the "Add to Cart" button, which will then redirect you to the payments page. Payments are made using a credit card and it is not necessary to have a PayPal account. If you do not have a PayPal account, please be sure to click on the white "Check Out" (Pay without a PayPal account) button.

In addition to PayPal, the group has recently started using a Square point of service (POS) device to allow members to make payments in-person by credit card.

During our monthly Sunday meetings, members are now able to present their credit card for payment and receive an email receipt. Although there is a fee for payments made using the Square service. those fees are now similarly covered by our treasury.

(NOTE: At the July 2 monthly meeting, a brief presentation and tutorial will provide additional details on using PayPal and Square services.)

Why Judge Overruled Tenn. Anti-Drag Law by Mark Satta, Assistant Professor Wayne State Univ.

The drag shows will go on. At least for now.

On June 2, 2023, Judge Thomas Parker, a Trump-appointed federal district court judge in western Tennessee, ruled that Tennessee's "Adult Entertainment Act" violated the First Amendment's free speech protection.

The act had been passed by the Tennessee Legislature and signed into law by Tennessee Gov. Bill Lee in March 2023. The law gained national attention because it appeared designed to limit drag performances through regulation of "male and female impersonators."

Parker provided several grounds for concluding that the law is unconstitutional. Using my experience as a First Amendment scholar, below I explain how Judge Parker reached those conclusions and what they mean for Tennessee's law.

### **Speech protections**

The First Amendment of the U.S. Constitution protects, among other things, free speech.

As Parker noted at the beginning of his opinion, "Freedom of speech is not just about speech. It is also about the right to debate with fellow citizens on self-government, to discover the truth in the marketplace of ideas, to express one's identity, and to realize self-fulfillment in a free society."

Freedom of speech protects more than just speech in the colloquial sense. It also protects many other ways that people express themselves, such as by waving a flag, marching in a parade or dancing.

Drag shows typically consist of various

forms of protected speech, like dancing, acting, lip-syncing, telling jokes and wearing elaborate outfits designed to send messages. Thus, any law seeking to limit drag performances raises important questions about whether that law violates the First Amendment.

Not all speech is protected by the First Amendment. Freedom of speech does not include the right to engage in, for example, perjury, defamation or threats of violence.

Freedom of speech also doesn't protect the narrow category of legally defined obscenity. According to the Supreme Court, something is legally obscene only if, applying contemporary community standards, a reasonable person would find that the work, when viewed holistically, appeals to prurient interests, contains patently offensive content and lacks any serious literary, artistic, political or scientific value.

Thus, as Parker noted, "there is a difference between material that is 'obscene' in the vernacular and material that is 'obscene' under the law," and the law imposes "an exceptionally high standard" for what counts as legally obscene.

The clearest example of sexually explicit material that does not receive First Amendment protection is child pornography. But the precise boundaries of what counts as legal obscenity are vague. Many kinds of sexually explicit material are not deemed legally obscene because it has often been relatively easy for litigants to convince modern courts that the material in question has serious literary, artistic, political or scientific value.

#### Unconstitutional restriction

Parker determined that the law targeted more than just legally obscene speech; it also targeted speech protected under the First Amendment.

The Supreme Court has set very high standards for when regulation of protected speech can discriminate based on the speech's content or viewpoint.

Content discrimination restricts speech based on subject matter. Viewpoint discrimination restricts speech based on the position taken. So, for example, a ban on speech about elections would discriminate based on content, while a ban on speech that is negative about a particular political candidate would discriminate based on viewpoint.

Parker concluded that the Tennessee law discriminated based on both the speech's content and its viewpoint.

He concluded that it discriminated based on content because it specifically targets "adult-oriented performances that are harmful to minors" and discriminates based on viewpoint because it specifically targets the speech of "male and female impersonators."

To make the point that the law discriminated based on viewpoint, Parker used an example of two Elvis impersonators dressed in revealing but nonobscene outfits. If one performer were male and the other female, the law would have made it more likely that the female Elvis impersonator would be subject to prosecution than the male Elvis impersonator. That discriminates against certain expressions

of gender identity.

Laws that discriminate based on viewpoint are subject to the highest standard of judicial review, known as strict scrutiny, which requires laws to be "narrowly tailored" and "well defined." Parker concluded that the law was neither. On this basis, he also concluded that it failed to meet the high standard of review and was unconstitutional.

He noted instead that on any plausible reading of the law, it "criminally sanctions qualifying performers virtually anywhere," including those performing in "private events at people's homes or arguably even age-restricted venues." He also wrote that the law appeared designed for the "impermissible purpose" of "chilling constitutionally-protected speech."

### Vague and overbroad

A vague law can violate a person's rights because it can be hard to tell if one is breaking the law.

Parker found the "harmful to minors" standard unconstitutionally vaque because what is harmful for different minors can change drastically depending on the minor. Consider, for example, the differences between a 5-year-old and a 17year-old. He also concluded that the law was overbroad because it covered, or could reasonably be interpreted to cover, many types of protected speech.

### Looking ahead

Parker's ruling barred enforcement of the law only in Shelby County. However, Parker's reasoning may also prove persuasive to judges assessing anti-drag laws in other states.
